Our Annual meeting was held by video conference in July. We bid a fond farewell to founding member Janet Flinkstrom as she retired from the Board. Janet attended our very first exploratory meeting back in 1998, was a signatory on our incorporation papers, and served as our first clerk. Although we couldn't meet in person, we still managed to celebrate her tenure and commitment to the Land Trust.

Towards the end of the year we began working with the Nashua River Watershed Association on a new Forest Legacy application. The Forest Legacy program is a land conservation program that assists landowners to receive federal funding for protecting their land. Projects take



several years to come to fruition, but we have successfully protected several parcels in Ashby previously and are hopeful to do more this round.

Two other local conservation successes also deserve comment here. The Trustees of Reservations purchased Jewell Hill Farm, preserving a lovely piece of our rural heritage. There are many trails and views on the property, which is open to the public. And at the very end of the year, our neighbors at the North County Land Trust successfully preserved the south peak of Mount Watatic. We are grateful and happy for both of these acquisitions which enhance the quality of life for us in Ashby as well as the larger community.
